Schedule for Document Verification (18.11.2019 to 27.11.2019)

1. The schedule for document verification (DV) for the provisionally shortlisted candidates for the posts of Junior Engineer (JE) against Centralized Employment Notice number (CEN No.) 03/2018 will be held from 18.11.2019 to 27.11.2019 as indicated below. **The roll numbers are not in the order of merit.**
2. The document verification will be held in the office of the Railway Recruitment Board, Trivandrum located near Thampanoor Police Station, Thampanoor, Trivandrum, PIN-695001. The following candidates will also be intimated through e-mail and SMS in their registered e-mail addresses and mobile numbers respectively.
3. The medical examination will be done on the next day of DV at any of the Railway hospitals located at Trivandrum and Palghat Divisions. After completion of DV, the candidates will be intimated about the hospital where they will have to undergo medical examination. They are required to be present in the hospital till completion of entire medical examination process and leave the hospital with due permission of the competent medical authority.
4. Candidates will be able to download their e-call letters for DV through the link which will be provided in the website of RRB, Trivandrum from 08.11.2019.
5. It must be noted that failure to report for the DV on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. **In such cases only, the candidates will be provided the last and final opportunity to appear in the DV on 27.11.2019 at 09.30 hrs at RRB/Trivandrum.**
6. The detailed instructions to candidates for DV are also attached.

**Instruction to Candidates for Document Verification and Medical Examination under
RRB/TVC for JE & DMS posts of CEN 03/2018**

1. While coming to the Document Verification (DV) you must bring the following Original Documents/Mark Sheets and Certificates (as applicable in your case) with you along with the e-call letter:-
 - (i) Matriculation/High School Examination Mark Sheet and Certificate or Equivalent certificate as Proof for Date of Birth. (The candidates' name and the father/ mother's name mentioned in the application will be verified with reference to the names mentioned in this certificate.)
 - (ii) 10 +2 / Inter / Higher Secondary/PUC Mark Sheet and Certificate (As applicable)
 - (iii) Diploma / Degree in Engineering Certificate with Semester wise Mark Sheets including back logs if any (As applicable).
 - (iv) SC / ST certificate in the format as per Annexure-I of CEN 03/2018.
 - (v) Valid OBC-NCL certificate in the format as per Annexure-II.
 - (vi) Non-creamy layer declaration by OBC candidates as per Annexure –IIA.
 - (vii) Income certificate for waiving examination fees for Economically Backward classes as per Annexure III / BPL Card / Izzat MST.
 - (viii) Minority Community Declaration affidavit on Non-Judicial Stamp paper as per Annexure – IV.
 - (ix) Original Discharge Certificate, Ex Servicemen pension book, Identity card for Ex-Servicemen clearly mentioning the reason of discharge and other details.
 - (x) Photo Copy of both sides of Aadhaar Card.
 - (xi) Medical Certificate for Persons with Benchmark Disabilities (PwBD) as per Annexures V (A), V (B), V(C), V (D).
 - (xii) NOC from Serving Employees with Date of Appointment. Ex-Servicemen candidates who secure civil employment after applying for this CEN should have given self declaration to the concerned employer about the details of application against this CEN, as soon as they had joined there. The acknowledged copy of this declaration along with NOC from the civil employer should be produced during DV.
 - (xiii) Self declaration for Ex-servicemen as per Annexure -VI
 - (xiv) Gazette Notification and/or any legal document in case of formal change of name (as mentioned in Para 1.7 of CEN 03/2018)/variation in spelling in name, father's name in the online application and original certificates/documents, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate(s) is one & same on the date of verification.
 - (xv) J&K Domicile Certificate.
 - (xvi) Certificate of eligibility from Government of India as per Para 4.0(f) of CEN 03/2018 on Nationality (For candidates other than citizen of India).
 - (xvii) Decree of Divorce/Judicial separation from the Competent Court of Law as applicable in case of divorcee/judicially separated women and affidavit stating that the candidate has not remarried.

- (xviii) Death certificate of spouse in case of widow candidates and affidavit stating that the candidate has not remarried.
 - (xix) The educational qualification certificates viz., provisional or Regular Diploma / Engineering/Science Degree Certificate with Semester wise Mark Sheets along with date of result (as applicable) should also contain the date of issue. In case, date of issue of these certificates is after the closing date of Notification, then the consolidated marks sheet with date of declaration of the final qualifying exam or individual marks sheets of all the semesters with date of declaration of each semester results should be submitted. In case of non-availability of date in any of these certificates, then a certificate indicating date of declaration of result from the Technical Board/ University to this effect should be produced at the time of DV.
 - (xx) Any other relevant certificate/testimonials/documents available with the candidate.
 - (xxi) 8 latest Passport size Colour Photographs.
 - (xxii) The candidates should also bring two (2) sets of clear & legible self-attested photocopies of all the original certificates/ documents mentioned above against (i) to (xx) as applicable.
2. If you fail to produce the above mentioned original certificates on the date of document verification, **your candidature is liable to be rejected and no further correspondence will be entertained in the matter.** Further, please note that furnishing false information, deliberate suppression of information or using unfair means at any stage of exam will render the candidate disqualified and he/she will be debarred from appearing in any selection or appointment in Railway or to other Government services and if appointed, the service of such candidate is liable to be terminated in future.
 3. Your candidature for above mentioned post(s) is purely provisional and subject to your fulfilling eligibility criteria in all respects.
 4. It may be noted that merely calling a candidate for Document Verification & Medical Examination does not in any way entitle him/her to an appointment in Railways. Please note that your empanelment will be subject to correctness of all the information submitted by you in your online application, CBTs/verification of documents.
 5. For SC/ST candidates the free travel authority is provided herewith, which may be used for availing free train travel for attending the office of RRB for Document Verification duly producing original caste certificate to authorized railway staff while traveling. For SC/ST candidates, the Free travel Authority for travelling to the place of Railway Hospital for Medical Examination and then to the home station of the candidate will be issued at RRB on completion of the DV.
 6. The candidates need to attend mandatory Medical Examination after Document Verification duly paying Rs.24/- towards medical examination fee. The date, time & place of Medical Examination will be intimated at the time of DV. Please note that you should be prepared to stay for 2 to 4 days for DV/Medical examination at your own cost till completion.

7. The reason for failure to report on the regular date of Document verification shall be supported by documentary evidence like sickness/university exams etc.,
8. **Block date for verification of original documents for absentee candidates:**
For the candidates who fail to report for the document verification on the regular dates assigned to them in their e-call letter, a second and final chance to attend the document verification is kept on the block date as mentioned in the DV schedule and uploaded on the RRB website. No fresh e-call letter will be sent for this purpose and the candidates can attend with the same e-call letter uploaded for the regular document verification.
9. Request for change of Block date assigned to the absentee candidates will not be entertained. The absentee candidates who do not attend the document verification on the block date i.e. on 27.11.2019 will forfeit their candidatures for any post of CEN.No:03/2018.
